Q.3. Solve Any Two:(With reasons) - (6 Marks each)

- a) Shanta, a young girl belonging to the tribal community is called to the police station along with a few family members, for inquiries regarding an offence. Later on the police constable asks her to stay back for further inquiries and tells all her family members to leave. When she is alone, the constable asks her to accompany him to a shed behind the police station. There, he asks her to remove her clothes and has sexual intercourse with her. At no stage Shanta resists or objects to these things. However, after a few days a case of rape is registered against the constable and Shanta states that the intercourse was without her consent.
 - i) Would the constable be guilty? Give reasons for your answer.
 - ii) Is this problem based on any decided case? Discuss the changes in law which were made after the case?

- b) A, B, C, D and E assemble together in an empty shed for stealing a valuable painting from Sheila's house.
